- The date of the photograph taken in Saputara must be mentioned compulsorily and it should be within the dates of the competition.
- Your entry must be entirely your own original work, not defame anybody nor breach any copyright for which you need to give a certificate stating the same.
- If your photograph features any person or people, they should be aware they were being photographed and permission should be obtained in writing from all involved (or their parents/guardians if under 15) for their photograph to be submitted in the competition. The copy of the permission letter should be furnished to TCGL. In case the permission is not obtained, TCGL is not liable for any disputes or any claim arising thereby. If it is clear that the people are not aware of their picture being taken or are embarrassed in any way in any entry we receive, the Panel reserves the right to disqualify the entry.
- Photographs to be submitted in 12 X 15 hard copy size along with soft copy in high resolution.
- Details of the subject must be clearly mentioned.
- The photographs submitted would be the property of TCGL and TCGL can use the photographs for promotion of Saputara, in any manner it desires. TCGL can use the photographs, irrespective of the entries

winning or not. No royalty payment or claim would be entertained for the submitted photographs.

- Due recognition would be given to the prize winning photographs.
- No payment would be made to the photographers for traveling or other expenses, related to photography of Saputara.
- The Panel reserves the right to cancel this competition at any stage, if deemed necessary in its opinion, and if circumstances arise outside its control.
- The Panel reserves the right to disqualify any entry which breaches any of these rules or to withhold a prize if in its opinion entries do not reach the required standard.
